Plaintiff demanded and defendant paid the available \$100,000 liability policy limits. An additional \$87,500 was paid by plaintiff's underinsured motorist carrier.

FACTS/CONTENTIONS

According to plaintiff: On June 4, 2009, plaintiff Victor Montalbo, a 59-year-old commercial real estate broker, was operating his 1988 Mercedes south on the 405 freeway when traffic slowed to a stop. Plaintiff's vehicle was rearended by defendant James's 2009 Nissan SUV.

Plaintiff alleged defendant was negligent in the operation of a motor vehicle and that all of plaintiff's claimed injuries were a direct result of the subject motor vehicle accident.

Defendant disputed the nature and extent of plaintiff's claimed injuries and the need for surgery.

According to plaintiff: As a direct result of the collision, plaintiff suffered injuries to his neck, shoulders, and back for which plaintiff received physical therapy. Plaintiff also sustained a concussion and tinnitus. Plaintiff's lumbar spine MRI revealed a 3-4 mm disc protrusion at L4-L5 and a 4-5 mm disc protrusion at L5-S1 with moderate canal and lateral recess stenosis. Plaintiff's orthopedist advised

plaintiff that he may require lumbar spine surgery in the future.
