FACTS/CONTENTIONS

According to plaintiff: On Oct. 20, 2012, plaintiff Miguel Orozco, a 30-year-old courier, drove his 1992 Nissan Sentra west on Texas Avenue in Los Angeles in the number 1 of 1 lanes and entered the intersection at Bundy Drive on a green light, when defendant Dillin, who was driving a 2003 Honda Civic, was northbound on Bundy Drive and ran the red light, causing a collision with plaintiff's vehicle.

Plaintiff alleged defendant was negligent in the operation of her vehicle and all of plaintiff's claimed injuries were a direct result of said negligence.

Defendant disputed liability, contending plaintiff ran the light. There were no eyewitnesses. Defendant further disputed the nature and extent of plaintiff's claimed injuries. Defendant claimed

plaintiff's injuries were pre-existing and he did not require surgery. Defendant further claimed that since the accident had occurred

CLAIMED INJURIES

According to plaintiff: Plaintiff sustained cervical and lumbar injuries for which he received physical therapy. Due to ongoing complaints plaintiff had a lumbar MRI, which revealed a 5 -6mm disc protrusion. A second MRI performed one year later revealed the disc had fully extruded and was 11mm x 18mm. Plaintiff underwent three epidural injections that failed to relieve the symptoms. Plaintiff may require surgical intervention in the form of a fusion and laminectomy and discectomy in the future.

CLAIMED DAMAGES

According to plaintiff: \$44,278 past medical; \$50,000 future medicals; \$10,000 lost earnings.
